#### MODE OF MEETING

The 28<sup>th</sup> AGM of the Company will be conducted virtually through live streaming from the Broadcast Venue and using Remote Participation and Voting ("**RPV**") facilities provided by Tricor Investor & Issuing House Services Sdn Bhd via TIIH Online website at <u>https://tiih.online</u>. The Broadcast Venue is strictly for the purpose of complying with Section 327(2) of the Companies Act 2016 which requires the Chairman of the meeting to be present at the main venue of the meeting. Members and proxies **WILL NOT BE ALLOWED** to attend this AGM in person at the Broadcast Venue on the day of the 28<sup>th</sup> AGM.

#### **RPV FACILITIES**

Shareholders are to attend, speak (in the form of real time submission of typed texts) and vote (collectively, "participate") remotely at the 28<sup>th</sup> AGM using RPV facilities from Tricor.

A shareholder who has appointed a proxy(ies) or attorney(s) or authorised representative(s) to participate at this 28<sup>th</sup> AGM via RPV must request his/her proxy(ies) or attorney(s) or authorised representative(s) to register himself/herself for RPV at TIIH Online website at https://tiih.online.

#### BEFORE THE 28<sup>TH</sup> AGM

(a)	Register as a user with TIIH Online	<ul> <li>Using your computer, access the website at <u>https://tiih.online</u>. Register as a user under the "e-Services" by selecting the "Sign Up" button and followed by "Create Account by Individual Holder". Refer to the tutorial guide posted on the homepage for assistance.</li> <li>Registration as a user will be approved within one (1) working day and you will be notified via e-mail.</li> <li>If you are already a user with TIIH Online, you are not required to register again. You will receive an e-mail to notify you that the remote participation is available for registration at TIIH Online.</li> </ul>	
(b)	Submit your request to attend the 28 <sup>th</sup> AGM remotely	<ul> <li>Registration is open from Friday, 28 April 2023 until the day of 28<sup>th</sup> AGM on Friday, 23 June 2023.</li> <li>Shareholder(s) or proxy(ies) or corporate representative(s) or attorney(s) are required to pre-register their attendance for the 28<sup>th</sup> AGM to ascertain their eligibility to participate in the 28<sup>th</sup> AGM using the RPV facilities.</li> <li>Login with your user ID (i.e. email address) and password and select the corporate event: "(REGISTRATION) MILUX CORPORATION BERHAD 28<sup>TH</sup> AGM".</li> <li>Read and agree to the Terms &amp; Conditions and confirm the Declaration.</li> <li>Select "Register for Remote Participation and Voting"</li> <li>Review your registration and proceed to register.</li> <li>System will send an e-mail to notify that your registration for remote participation is received and will be verified.</li> <li>After verification of your registration against the General Meeting Record of Depositors as at 19 June 2023, the system will send you an e-mail on 21 June 2023 to approve or reject your registration for remote participation.</li> <li>(Note: Please allow sufficient time for approval of new user of TIIH Online and registration for the RPV).</li> </ul>

(a)	Login to TIIH Online	<ul> <li>Login with your user ID and password for remote participation at the 28<sup>th</sup> AGM at any time from 1.30 p.m. i.e. 1 hour before the commencement of the 28<sup>th</sup> AGM on Friday, 23 June 2023 at 2.30 p.m.</li> </ul>		
(b)	Participate through Live Streaming	<ul> <li>Select the corporate event: "(LIVE STREAM MEETING) MILUX CORPORATION BERHAD 28<sup>TH</sup> AGM" to engage in the proceedings of the 28<sup>th</sup> AGM remotely.</li> <li>If you have any question for the Chairman/ Board, you may use the query box to transmit your question. The Chairman/ Board will endeavor to respond to questions submitted by remote participants during the AGM. If there is time constraint, the responses will be e-mailed to you at the earliest possible, after the meeting.</li> </ul>

(c)	Online Remote Voting	<ul> <li>Voting session commences from 2.30 p.m. on Friday, 23 June 2023 until a time when the Chairman announces the end of the session.</li> <li>Select the corporate event: "(REMOTE VOTING) MILUX CORPORATION BERHAD 28<sup>TH</sup> AGM" or if you are on the live stream meeting page, you can select "GO TO REMOTE VOTING PAGE" button below the Query Box.</li> <li>Read and agree to the Terms &amp; Conditions and confirm the Declaration.</li> <li>Select the CDS account that represents your shareholdings.</li> <li>Indicate your votes for the resolutions that are tabled for voting.</li> <li>Confirm and submit your votes.</li> </ul>
(d)	End of remote participation	• Upon the announcement by the Chairman on the closure of the 28 <sup>th</sup> AGM, the Live Streaming will end.

#### Note to users of the RPV facilities:

- 1. Should your registration for the RPV facilities be approved, we will make available to you the right to join the live stream meeting and to vote remotely. Your login to TIIH Online on the day of meeting will indicate your presence at the virtual meeting.
- 2. The quality of your connection to the live broadcast is dependent on the bandwidth and stability of the internet at your location and the device you use.

#### **Entitlement to Participate and Appointment of Proxy**

- Only members whose names appear on the Record of Depositors as at 19 June 2023 shall be eligible to participate, speak and vote at the 28<sup>th</sup> AGM or appoint a proxy(ies) and/or the Chairman of the meeting to attend and vote on his/her behalf.
- If you are not able to participate in the 28<sup>th</sup> AGM remotely, you are encouraged to appoint the Chairman of the meeting as your proxy and indicate the voting instruction in the Proxy Form.
- If you wish to participate in the 28<sup>th</sup> AGM yourself, please do not submit any Proxy Form for the AGM. You will not be allowed to participate in the AGM together with a proxy appointed by you. If you have submitted your Proxy Form prior to the 28<sup>th</sup> AGM and subsequently decide to personally participate in the AGM, please write in to <u>is.enquiry@my.tricorglobal.com</u> to revoke the earlier appointment of your proxy(ies) at least 48 hours before the commencement of the AGM.
